## Sweetwater

Sweetwater is a county in Wyoming with 5,292 residents age 65 or older. There are approximately 142 Native American residents age 55 or older. Compared to state average rates, older residents in Sweetwater County are less likely to have a college degree. They are less likely to take the health promotion steps of meeting the CDC guidelines for musclestrengthening activity or eat 5 or more servings of fruits and vegetables per day. The most prevalent chronic conditions among people age 65+ in Sweetwater County are hypertension ( $41 \%$ ), arthritis ( $24 \%$ ), and high cholesterol ( $23 \%$ ). Community resources to support healthy aging include $87 \%$ with a regular doctor, a hospital, 2 home health agencies, a community center, 2 nursing homes, an adult day health center, a hospice agency, and 2 senior centers.

## TECHNICAL NOTES

*See our technical report for more detailed information on data sources, measures, and methodology. For most indicators the county and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and county estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between county and state estimates that we are confident are not due to chance. "Better" is used where a higherllower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
