Newport (Newport)

Newport is a city in Newport County with 5,092 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of tooth loss, Alzheimer's disease, anemia, chronic kidney disease, COPD, congestive heart failure (CHF), diabetes, glaucoma, heart attack, hypertension, ischemic heart disease, liver disease, peripheral vascular disease, high cholesterol, tobacco use disorder, and anxiety disorder. However, they have a higher rate of cataract. They are more likely to take the health promotion steps of getting adequate sleep, engaging in physical activity, meeting the CDC guidelines for aerobic exercise, receiving flu, pneumonia, and shingles vaccines, and having an annual dental exam. Community resources to support healthy aging include an adult day health center, one public university or community college, one public library, one assisted living facility, one senior center, one hospital, two community health centers, three skilled nursing facilities, and 23 primary care providers. Newport is a designated AARP Age-Friendly Community.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
