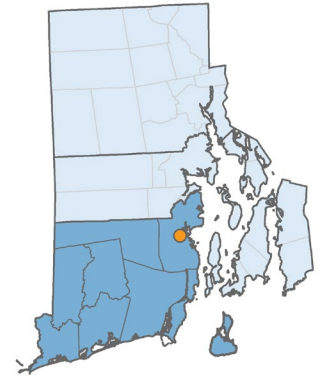


North Kingstown (Washington)

North Kingstown is a town in Washington County with 5,766 residents aged 65 and older. Compared to state rates, older residents in North Kingstown have lower rates of tooth loss, Alzheimer's disease, anemia, chronic kidney disease, chronic obstructive pulmonary disease, congestive heart failure, diabetes, heart attack, hypertension, ischemic heart disease, osteoporosis, peripheral vascular disease, pressure ulcer, stroke, depression, anxiety disorder, and schizophrenia. However, they reported higher rates of cataract and glaucoma. They are more likely to take the health promotion steps of getting adequate sleep, engaging in physical activity, meeting the CDC guidelines for strength training and aerobic activity, receiving shingles vaccines, having a regular doctor, and having dental insurance and annual dental exams. They were also more likely to report being stressed about buying food. Community resources to support healthy aging include one senior center, one community health center, three skilled nursing facilities, three public libraries, and 11 primary care providers.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
