Pawtucket (Providence)

Pawtucket is a city in Providence County with 9,825 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of benign prostatic hyperplasia, breast cancer, cataract, glaucoma, high cholesterol and osteoarthritis/rheumatoid arthritis. However, they have higher rates of tooth loss, asthma, diabetes, depression, and substance and tobacco use disorders. They are less likely to take the health promotion steps of engaging in physical activity, meeting the CDC guidelines for strength training and aerobic activity, receiving flu and shingles shots, or being screened for colorectal cancer. In addition, they are more likely to smoke. Community resources to support healthy aging include one public library, one senior center, an Alzheimer's caregiver support group, one hospice agency, two home health agencies, three skilled nursing facilities, three community health centers, three adult day health centers, four assisted living facilities, and 58 primary care providers.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
