

Tiverton (Newport)

Tiverton is a town in Newport County with 3,891 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of tooth loss, anemia, peripheral vascular disease, and tobacco use disorder. However, they have higher rates of atrial fibrillation, chronic kidney disease, fibromyalgia/chronic pain/fatigue, liver disease, high cholesterol, and osteoporosis. They are more likely to take the health promotion steps of getting adequate sleep, engaging in physical activity, meeting the CDC aerobic activity guidelines, receiving flu, pneumonia, and shingles vaccines, and having annual dental exams. They are also more likely to report being stressed about buying food. Community resources to support healthy aging include one senior center, one assisted living facility, two public libraries, and five primary care providers.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
