Providence Other (Providence)

Providence Other is a neighborhood of Providence with 30,447 residents aged 65 and older. Older residents have lower than state rates of hip fracture, atrial fibrillation, benign prostatic hyperplasia, breast cancer, cataract, COPD, fibromyalgia, glaucoma, ischemic heart disease, lung cancer, migraine, high cholesterol, osteoarthritis, osteoporosis, and anxiety disorder. However, they have higher rates of tooth loss, Alzheimer's disease, CKD, diabetes, substance/tobacco use disorders, PTSD, and schizophrenia. They are less likely to have an annual dental exam, cholesterol screening, adequate sleep, physical activity, or be vaccinated for flu, pneumonia, or shingles. They report being stressed about buying food and not seeing a doctor when needed due to cost. Community resources include 2 hospice agencies, 3 assisted living facilities, 3 hospitals, 3 senior centers, 1 Alzheimer's caregiver support group, 4 public universities/community colleges, 5 skilled nursing facilities, 5 adult day health centers, 6 home health agencies, 8 public libraries, 13 community health centers, and 242 PCPs.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
