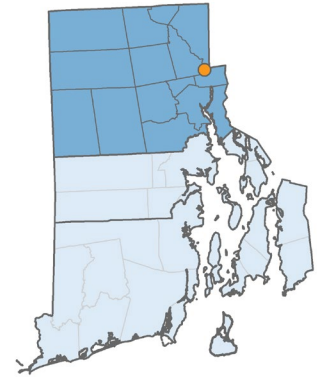


Central Falls (Providence)

Central Falls is a city in Providence County with 1,909 residents aged 65 and older. Compared to state average rates, older residents demonstrate lower rates of atrial fibrillation, benign prostatic hyperplasia, breast cancer, cataract, glaucoma, osteoarthritis/rheumatoid arthritis, osteoporosis, and high cholesterol. However, they have higher rates of tooth loss, Alzheimer's disease or related dementias, diabetes, and schizophrenia. They are more likely to take the health promotion steps of engaging in physical activity, meeting the CDC guidelines for aerobic and muscle-strengthening activity, receiving a flu shot and shingles vaccine, getting screened for colorectal cancer, and having an annual dental exam. Community resources to support healthy aging include an adult day health center, one public university or community college, one public library, two skilled nursing facilities, three community health centers, and ten primary care providers.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Rhode Island Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
