
## Norwich (New London)

Norwich is a city in New London County with 6,402 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of cataract, glaucoma, and traumatic brain injury. However, they had higher rates of obesity, high cholesterol, tooth loss, anemia, asthma, chronic kidney disease, COPD, colon cancer, CHF, diabetes, endometrial cancer, heart attack, fibromyalgia/chronic pain/fatigue, hypertension, hypothyroidism, ischemic heart disease, liver disease, lung cancer, osteoarthritis or rheumatoid arthritis, peripheral vascular disease, stroke, substance and tobacco use disorders, depression, anxiety and bipolar disorders, PTSD, and schizophrenia. They are more likely to take the health promotion steps of having an annual physical exam and wearing a seatbelt while driving. However, they are less likely to have an annual dental exam, get a flu shot, do any physical activity within the last month, and meet the CDC guidelines for doing aerobic physical and muscle-strengthening activities. Community resources include 89 primary care providers, a hospital and 3 nursing homes within 5 miles; 6 hospice agencies, 2 community health centers, a caregiver support group, a senior center, an assisted living site, a university or community college, and a public library.

## TECHNICAL NOTES

\*See our technical report (online at <u>https://healthyagingdatareports.org</u>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
