
Trumbull (Fairfield)

FOUNDATION

Trumbull is a town in Fairfield County with 6,792 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of obesity, tooth loss, COPD, opioid, tobacco, substance use disorders, personality and bipolar disorders, PTSD, and schizophrenia or other psychotic disorders. However, they had higher rates of hip fracture, high cholesterol, Alzheimer's disease or related dementias, anemia, atrial fibrillation, benign prostatic hyperplasia, cataract, CHF, fibromyalgia/chronic pain/fatigue, hypertension, hypothyroidism, ischemic heart disease, osteoporosis, peripheral vascular disease, pressure ulcers, prostate cancer, stroke, anxiety disorder, and hearing impairment. They are more likely to be nonsmokers and take the health promotion step of meeting the CDC guidelines for aerobic physical activity. Community resources to support healthy aging include 319 primary care providers, a hospital, and 8 nursing homes within 5 miles; a caregiver support group, 36 home health agencies, an adult day health center, 10 hospice agencies, a senior center, 2 public libraries, and 2 assisted living sites.

TECHNICAL NOTES

*See our technical report (online at <u>https://healthyagingdatareports.org</u>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
