
Waterbury (New Haven)



Waterbury is a city in New Haven County with 14,108 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of atrial fibrillation, breast cancer, cataract, hypothyroidism, leukemias and lymphomas, and osteoporosis, However, they had higher rates of obesity, high cholesterol. tooth loss. Alzheimer's disease or related dementias, anemia, chronic kidney disease. COPD, CHF, diabetes, epilepsy, glaucoma, heart attack, hypertension, ischemic heart disease, migraine or other chronic headache, osteoarthritis or rheumatoid arthritis, peripheral vascular disease, pressure ulcers, stroke, substance and tobacco use disorders, depression, anxiety and bipolar disorders, schizophrenia or other psychotic disorders, hearing, visual, and mobility impairments. They are more likely to be stressed about paying rent/mortgage in the last month. Community resources to support healthy aging include 190 primary care providers, 2 hospitals, and 10 nursing homes within 5 miles; 3 caregiver support groups, 37 home health agencies, 4 community health centers, 3 adult day health centers, 11 hospice agencies, 4 senior centers, 4 universities or community colleges, 2 public libraries, a YMCA, and an assisted living site.

TECHNICAL NOTES

*See our technical report (online at https://healthyagingdatareports.org) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
