
## **Bridgeport (Fairfield)**



Bridgeport is a city in Fairfield County with 15.638 residents age 65 or older. Compared to state average rates, older residents had lower rates of atrial fibrillation, breast cancer, cataract, fibromyalgia, osteoarthritis, leukemias/lymphomas, and hearing impairment. However, they had higher rates of obesity, tooth loss, Alzheimer's disease, anemia, asthma, chronic kidney disease, colon cancer, CHF, diabetes, epilepsy, heart attack, hypertension. ischemic heart disease, liver disease, osteoporosis, peripheral vascular disease, pressure ulcers, stroke, schizophrenia, substance/tobacco use disorders, and mobility impairment. They were less likely to get the recommended hours of sleep, follow the CDC guidelines for aerobic physical activity, get flu/pneumonia/shingles vaccines, be screened for colorectal cancer, or follow CDC preventive health screening goals. They are also less likely to have an annual dental exam, more likely to be stressed about buying food, and less likely to see a doctor due to cost. Community resources include 308 primary care providers, 3 hospitals and 7 nursing homes within 5 miles; 39 home health agencies, 13 community health centers, 11 hospice agencies, 6 senior centers, 2 caregiver support groups, 2 universities/community colleges, adult day health center, assisted living site, and 5 public libraries.

## TECHNICAL NOTES

\*See our technical report (online at <a href="https://healthyagingdatareports.org">https://healthyagingdatareports.org</a>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
