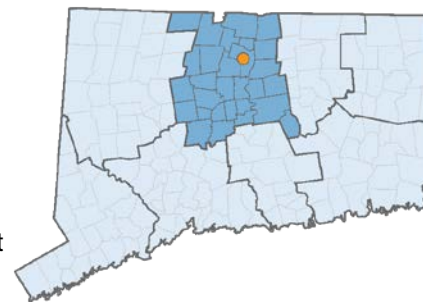


Windsor (Hartford)

Windsor is a town in Hartford County with 5,147 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, anemia, asthma, atrial fibrillation, benign prostatic hyperplasia, cataract, COPD, fibromyalgia/chronic pain/fatigue, hypothyroidism, ischemic heart disease, liver disease, lung cancer, migraine, osteoarthritis or rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcers, stroke, traumatic brain injury, opioid use disorder, depression, anxiety and bipolar disorders, and personality disorders; and hearing impairment. However, they had higher rates of obesity, glaucoma, and prostate cancer. They are more likely to take the health promotion steps of having a regular doctor, dental insurance, and always wearing a seatbelt and less likely to get a colorectal cancer screening. They are also less likely to engage in excessive drinking. Community resources to support healthy aging include 10 primary care providers and 5 nursing homes within 5 miles; 29 home health agencies, 11 hospice agencies, a caregiver support group, a community health center, an adult day health center, a senior center, and 2 public libraries.

TECHNICAL NOTES

*See our technical report (online at <https://healthyagingdatareports.org>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
