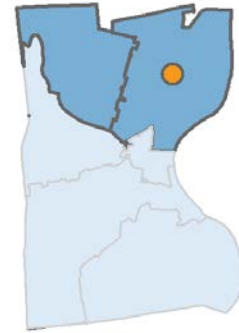


Hartford Area1 (Hartford)

Hartford Area 1 is a Northern neighborhood of Hartford in Hartford County with 3,895 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of hip fracture, high cholesterol, atrial fibrillation, benign prostatic hyperplasia, cataract, fibromyalgia/chronic pain/fatigue, hypothyroidism, migraine, osteoporosis, depression, anxiety and personality disorders, and hearing impairment. However, they had higher rates of tooth loss, obesity, anemia, asthma, chronic kidney disease, CHF, diabetes, glaucoma, hypertension, prostate cancer, tobacco use disorder, and visual and mobility impairment. They are less likely to take the health promotion steps of doing physical activity, meeting the CDC guidelines for aerobic physical activity, getting a flu shot, shingles vaccine, and having an annual dental exam. They are also more likely to be stressed about buying food in the past month. Community resources to support healthy aging include 2 primary care providers within 5 miles, 10 hospice agencies, a community health center, a caregiver support group, and a senior center.

TECHNICAL NOTES

*See our technical report (online at <https://healthyagingdatareports.org>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
