Hartford Area2 (Hartford)



Hartford Area 2 is a Western neighborhood of Hartford in Hartford County with 2.732 residents age 65 or older. Compared to state average rates, older residents had lower rates of atrial fibrillation, endometrial cancer, fibromyalgia/chronic pain/fatigue, heart attack, and osteoarthritis or rheumatoid arthritis. However, they had higher rates of tooth loss, Alzheimer's disease, anemia, asthma, chronic kidney disease, CHF, diabetes, epilepsy. hypothyroidism, liver disease, osteoporosis, peripheral vascular disease, pressure ulcers, stroke, traumatic brain injury, opioid/substance/tobacco use disorders; PTSD, depression, anxiety/bipolar/personality disorders; schizophrenia, and hearing/visual/mobility impairments. They are likely to be current smokers and less likely to have a regular doctor. do physical activity, meet the CDC guidelines for aerobic physical activity, get flu/shingles vaccines, and have annual dental exams. They are also more likely to be stressed about buying food in the past month. Community resources to support healthy aging include 45 primary care providers, a hospital, and a nursing home within 5 miles; 8 hospice agencies, 7 universities or community colleges, 2 senior centers, a caregiver support group, a community health center, a home health agency, an adult day health center, a public library, and a YMCA.

TECHNICAL NOTES

*See our technical report (online at https://healthyagingdatareports.org) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
