

## **Darien (Fairfield)**

Darien is a town in Fairfield County with 2,618 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of obesity, high cholesterol, tooth loss, anemia, asthma, chronic kidney disease, COPD, CHF, diabetes, epilepsy, heart attack, hypertension. hypothyroidism, ischemic heart disease, liver disease, peripheral vascular disease, opioid and tobacco use disorders, depression, anxiety, bipolar, and personality disorders; PTSD, schizophrenia and other psychotic disorders, and visual and mobility impairments. However, they had higher rates of breast cancer, glaucoma, and traumatic brain injury. They are more likely to take the health promotion steps of getting the recommended hours of sleep, doing any physical activity within the last month, and meeting the CDC guidelines for muscle strengthening activity. They are also more likely to engage in excessive drinking, and less likely to have a regular doctor, and an annual physical exam. Community resources to support healthy aging include 164 primary care providers, 4 nursing homes, and a hospital within 5 miles; 21 home health agencies, 9 hospice agencies, a caregiver support group, an assisted living site, a senior center, a public library, and a YMCA.

## TECHNICAL NOTES

\*See our technical report (online at <a href="https://healthyagingdatareports.org">https://healthyagingdatareports.org</a>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
