

## **Avon (Hartford)**

Avon is a town in Hartford County with 3,824 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of obesity, tooth loss, asthma, chronic kidney disease, COPD, CHF, diabetes, epilepsy, fibromyalgia/chronic pain/fatigue, heart attack, hypertension, ischemic heart disease, liver disease, osteoarthritis or rheumatoid arthritis, peripheral vascular disease, pressure ulcers, stroke, opioid use, substance and tobacco disorders, bipolar disorder, and mobility impairment. However, they had higher rates of breast cancer, cataract, glaucoma, hypothyroidism, osteoporosis, prostate cancer, and hearing impairment. They are more likely to take the health promotion steps of doing physical activity, getting a shingles vaccine, having an annual dental exam, and always wearing a seatbelt. Community resources to support healthy aging include 93 primary care providers and 3 nursing homes within 5 miles; 28 home health agencies, 10 hospice agencies, 3 caregiver support groups, 2 adult day health centers, 2 assisted living sites, a senior center, and a public library.

## TECHNICAL NOTES

\*See our technical report (online at <u>https://healthyagingdatareports.org</u>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
