

Farmington (Hartford)

Farmington is a town in Hartford County with 4,998 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of obesity, tooth loss, asthma, benign prostatic hyperplasia, chronic kidney disease, COPD, diabetes, epilepsy, fibromyalgia/chronic pain/fatique, ischemic heart disease, osteoarthritis or rheumatoid arthritis, peripheral vascular disease, stroke, opioid, substance, and tobacco use disorders; bipolar and personality disorders, and schizophrenia and other psychotic disorders. However, they had higher rates of Alzheimer's disease or related dementias, atrial fibrillation, breast cancer, cataract, glaucoma, osteoporosis, and hearing impairment. They are more likely to take the health promotion steps of doing any physical activity within the last month, getting a shingles vaccine, and having an annual dental exam. They also report always wearing a seatbelt when driving or riding. Community resources to support healthy aging include 190 primary care providers, 8 nursing homes, and a hospital within 5 miles; 4 caregiver support groups, 33 home health agencies, 15 hospice agencies, 2 assisted living facilities, 2 universities or community colleges, 2 public libraries, and senior center.

TECHNICAL NOTES

*See our technical report (online at https://healthyagingdatareports.org) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
