

## **Greenwich (Fairfield)**

Greenwich is a town in Fairfield County with 10,534 residents age 65 or older. Compared to state average rates, older residents had lower rates of obesity, tooth loss, asthma, cataract, chronic kidney disease, COPD, CHF, diabetes, heart attack, hypertension, ischemic heart disease, liver disease, peripheral vascular disease. opioid, substance, and tobacco use disorders; depression, anxiety, bipolar, and personality disorders; PTSD, schizophrenia and other psychotic disorders, and visual and mobility impairments. However, they had higher rates of hip fracture, anemia, atrial fibrillation, benign prostatic hyperplasia, breast cancer, fibromyalgia/chronic pain/fatigue, glaucoma, hypothyroidism, prostate cancer, and hearing impairment. They are more likely to take the health promotion step of not smoking, but are less likely to have an annual physical exam, dental insurance, or get a pneumonia vaccine. Community resources to support healthy aging include 196 primary care providers, 3 nursing homes, and 2 hospitals within 5 miles; 18 home health agencies, 7 hospice agencies, 3 caregiver support groups, 3 assisted living sites, 4 public libraries, a community health center, an adult day health center, a senior center, and a YMCA. Greenwich is a designated Age-Friendly community.

## TECHNICAL NOTES

\*See our technical report (online at <a href="https://healthyagingdatareports.org">https://healthyagingdatareports.org</a>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
