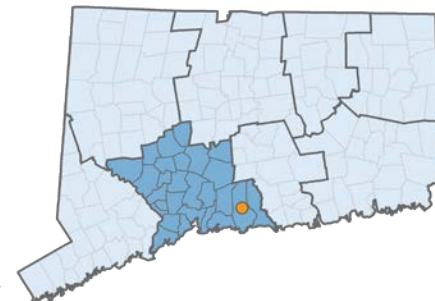


Guilford (New Haven)

Guilford is a town in New Haven County with 5,071 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of falls, obesity, high cholesterol, tooth loss, Alzheimer’s disease or related dementias, anemia, asthma, chronic kidney disease, COPD, colon cancer, congestive heart failure, diabetes, epilepsy, heart attack, hypertension, ischemic heart disease, peripheral vascular disease, pressure ulcers, stroke, substance and tobacco use disorders, anxiety disorder, schizophrenia and other psychotic disorders, and hearing, visual, and mobility impairments. However, they had higher rates of cataract. They are more likely to take the health promotion steps of doing any physical activity within the last month, meeting the CDC guidelines for aerobic physical activity, and getting a cholesterol screening and shingles vaccine. Community resources to support healthy aging include 36 primary care providers and 4 nursing homes within 5 miles; 24 home health agencies, 8 hospice agencies, a caregiver support group, a senior center, and a public library.

TECHNICAL NOTES

*See our technical report (online at <https://healthyagingdatareports.org>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
