
## Meriden (New Haven)



Meriden is a city in New Haven County with 9,980 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of cataract, glaucoma, prostate cancer, and hearing impairment. However, they had higher rates of obesity, tooth loss, Alzheimer's disease or related dementias, chronic kidney disease, COPD, diabetes, epilepsy, hypertension, liver and peripheral vascular diseases. osteoarthritis or rheumatoid arthritis, pressure ulcers, stroke, opioid, substance, and tobacco use disorders, depression, anxiety and bipolar disorders, schizophrenia and other psychotic disorders, and personality disorder. They are more likely to take the health promotion step of getting cholesterol screening. However, they are less likely to do any physical activity within the last month, meet the CDC guidelines for aerobic physical activity, and more likely to use e-cigarettes in the last month. Community resources to support healthy aging include 191 primary care providers, a hospital, and 6 nursing homes within 5 miles; a caregiver support group, 38 home health agencies, a community health center, 12 hospice agencies, 2 senior centers, 3 universities or community colleges, a public library, a YMCA, and an assisted living site.

## TECHNICAL NOTES

\*See our technical report (online at <a href="https://healthyagingdatareports.org">https://healthyagingdatareports.org</a>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
