

New Britain (Hartford)

New Britain is a city in Hartford County with 9,355 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of high cholesterol, benign prostatic hyperplasia, breast cancer, colon cancer, fibromvalqia/chronic pain/ fatique, glaucoma, hypothyroidism, leukemias and lymphomas, osteoporosis, prostate cancer, and hearing impairment. However, they had higher rates of Alzheimer's disease or related dementias, anemia, asthma, atrial fibrillation, chronic kidney disease, COPD, congestive heart failure, diabetes, heart attack, hypertension, ischemic heart disease, pressure ulcers, stroke, opioid use disorder, substance use disorder, tobacco use disorder, depression, bipolar disorder, schizophrenia and other psychotic disorders, personality disorder, and mobility impairment. They are less likely to take the health promotion step of getting colorectal cancer screenings. Community resources to support healthy aging include 135 primary care providers. a hospital, and 10 nursing homes within 5 miles; 3 caregiver support groups, 38 home health agencies, 2 community health centers, 11 hospice agencies, 2 senior centers, 3 universities or community colleges, 2 public libraries, and a YMCA.

TECHNICAL NOTES

*See our technical report (online at https://healthyagingdatareports.org) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
