
## **Bethel (Fairfield)**



Bethel is a town in Fairfield County with 2,915 residents age 65 or older. Compared to state average rates, older residents fared better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, anemia, atrial fibrillation, breast cancer, congestive heart failure, diabetes, glaucoma, heart attack, hypertension, hypothyroidism, substance use disorder, depression, and hearing impairment. However, they had higher rates of obesity, epilepsy, and peripheral vascular disease. Community resources to support healthy aging include 175 primary care providers, a hospital, and 6 nursing homes within 5 miles; 11 home health agencies, 4 hospice agencies, a senior center, a university or community college, and a public library. There are age-friendly efforts underway in the community.

## TECHNICAL NOTES

\*See our technical report (online at <a href="https://healthyagingdatareports.org">https://healthyagingdatareports.org</a>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an \*.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
