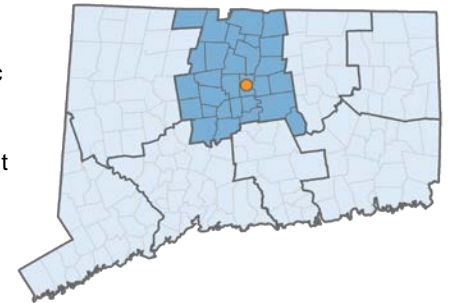


Hartford (Hartford)

Hartford is a city in Hartford County with 13,258 residents age 65 or older. Compared to state average rates, older residents fared better with lower rates of hip fracture, high cholesterol, atrial fibrillation, benign prostatic hyperplasia, cataract, endometrial/lung cancers, leukemias, hypothyroidism, fibromyalgia/chronic pain/fatigue, migraine, and osteoarthritis or rheumatoid arthritis. However, they had higher rates of obesity, Alzheimer's disease, anemia, asthma, COPD, CHF, diabetes, epilepsy, glaucoma, hypertension, chronic kidney/ischemic heart/liver/peripheral vascular diseases, pressure ulcers, stroke, opioid/substance/tobacco use disorders, anxiety/mood/personality disorders, PTSD, schizophrenia, tooth loss, and mobility/visual impairments. They are more likely to be current smokers and to be stressed about buying food, and are less likely to meet the CDC guidelines for aerobic physical activity, have flu and shingles vaccines, annual dental exams, and a regular doctor. Community resources include 310 PCPs, 3 hospitals, and 9 nursing homes within 5 miles; 5 caregiver support groups, 47 home health agencies, 5 community health centers, 4 adult day health centers, 12 hospice agencies, 5 senior centers, 8 universities/community colleges, 7 public libraries, a YMCA, and an assisted living site.

TECHNICAL NOTES

*See our technical report (online at <https://healthyagingdatareports.org>) for more information on data sources, measures, geographic units, margins of error, and statistical methodology. For most indicators the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. "Better" is used where a higher/lower value has positive implications for the health of older residents. "Worse" is used where a higher/lower score has negative implications for the health of older people, and when the implication is unclear, we use an *.

We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed we used a hierarchical approach to reporting.
