Portland (Middlesex)

Portland is a town in Middlesex County with 1,604 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of anemia, benign prostatic hyperplasia, osteoporosis, and prostate cancer. However, they have higher rates of breast cancer, substance and tobacco use disorders, and anxiety disorder. Older residents in Middlesex County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (79.1%) and annual dental exams (74.4%), while 56.1% of men and 47.6% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one assisted living facility, 29 primary care providers, one skilled nursing facility, four community health centers, one senior center, and one public library.
