
Stamford (Fairfield)

Stamford is a city in Fairfield County with 20,725 residents aged 65 and older. Compared to state average rates, older residents have lower rates of asthma, cataract, chronic kidney disease, COPD, CHF, heart attack, hypertension, liver disease, peripheral vascular disease, substance and tobacco use disorders, depression, anxiety disorder, PTSD, and schizophrenia. However, they have higher rates of anemia, benign prostatic hyperplasia, diabetes, fibromyalgia, glaucoma, ischemic heart disease, migraine, and prostate cancer. Older residents in Fairfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.6%) and annual dental exams (72.4%), while 49.5% of men and 44.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include eight assisted living facilities, 129 primary care providers, one hospital, one home health agency, five skilled nursing facilities, one hospice agency, 32 community health centers, four senior centers, one public university or community college, and four public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
