
Trumbull (Fairfield)

Trumbull is a town in Fairfield County with 6,252 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of substance and tobacco use disorders and PTSD. However, they have higher rates of hip fracture, Alzheimer's disease or related dementias, anemia, atrial fibrillation, benign prostatic hyperplasia, cataract, fibromyalgia/chronic pain/fatigue, hypertension, high cholesterol, ischemic heart disease, osteoporosis, peripheral vascular disease, pressure ulcer, prostate cancer, and stroke. Older residents in Fairfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.6%) and annual dental exams (72.4%), while 49.5% of men and 44.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include four assisted living facilities, 53 primary care providers, one home health agency, two skilled nursing facilities, one community health center, one senior center, and two public libraries.
