
Bridgeport (Fairfield)

Bridgeport is a city in Fairfield County with 20,091 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of atrial fibrillation, breast cancer, cataract, high cholesterol, osteoarthritis/rheumatoid arthritis, and anxiety disorder. However, they have higher rates of Alzheimer's disease, anemia, asthma, chronic kidney disease, congestive heart failure (CHF), diabetes, hypertension, liver disease, peripheral vascular disease, pressure ulcer, stroke, substance and tobacco use disorders, and schizophrenia. Older residents in Fairfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.6%) and annual dental exams (72.4%), while 49.5% of men and 44.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 3 assisted living facilities, 190 primary care providers, 3 hospitals, 2 home health agencies, 3 skilled nursing facilities, 2 hospice agencies, 38 community health centers, an Alzheimer's caregiver support group, 3 adult day health centers, 6 senior centers, 2 public universities or community colleges, and 6 public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
