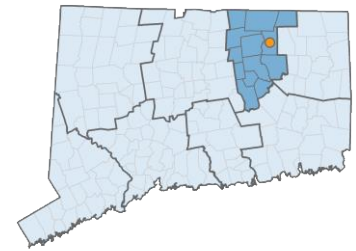


## Willington (Tolland)

Willington is a town in Tolland County with 1,184 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, Alzheimer's disease or related dementias, anemia, benign prostatic hyperplasia, diabetes, fibromyalgia/chronic pain/fatigue, high cholesterol, hypertension, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcer, prostate cancer, depression, anxiety disorder, and schizophrenia. However, they have a higher rate of tobacco use disorder. Older residents in Tolland County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (77.3%) and annual dental exams (72.6%), while 50.2% of men and 45.8% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one assisted living facility, two community health centers, one senior center, and one public library.

## TECHNICAL NOTES

\*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at ([healthyagingdatareports.org](http://healthyagingdatareports.org)). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
