
A3 Bridgeport (Fairfield)

Bridgeport Area 3 is an Eastern neighborhood of Bridgeport in Fairfield County with 9,494 residents aged 65 and older. Compared to state averageates, older residents have lower rates of hip fracture, atrial fibrillation, benign prostatic hyperplasia, breast cancer, cataract, osteoarthritis/rheumatoid arthritis, osteoporosis, and anxiety disorder. However, they have higher rates of Alzheimer's disease, anemia, asthma, chronic kidney disease, congestive heart failure (CHF), diabetes, hypertension, liver disease, peripheral vascular disease, pressure ulcer, substance and tobacco use disorders, and schizophrenia. Older residents in Fairfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.6%) and annual dental exams (72.4%), while 49.5% of men and 44.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 162 primary care providers, two hospitals, two skilled nursing facilities, 17 community health centers, two senior centers, and three public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
