
A1 Hartford (Hartford)

Hartford Area 1 is a Northern neighborhood of Hartford in Hartford County with 9,075 residents aged 65 and older. Compared to state average rates, older residents have lower rates of atrial fibrillation, benign prostatic hyperplasia, cataract, endometrial cancer, fibromyalgia/chronic pain/fatigue, osteoarthritis/rheumatoid arthritis, high cholesterol, and anxiety disorder. However, they have higher rates of Alzheimer's disease or related dementias, anemia, asthma, chronic kidney disease, congestive heart failure (CHF), diabetes, hypertension, substance and tobacco use disorders, PTSD, and schizophrenia. Older residents in Hartford County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (77.9%) and annual dental exams (69.2%), while 46.5% of men and 47.1% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 17 primary care providers, one hospital, one home health agency, one skilled nursing facility, three community health centers, one senior center, and three public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
