A3 Stamford (Fairfield)

Stamford Area 3 is a Western neighborhood of Stamford in Fairfield County with 13,216 residents aged 65 and older. Compared to state average rates, older residents have lower rates of asthma, atrial fibrillation, cataract, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), heart attack, liver disease, substance and tobacco use disorders, depression, anxiety disorder, PTSD, and schizophrenia. However, they have higher rates of benign prostatic hyperplasia, diabetes, fibromyalgia/chronic pain/fatigue, glaucoma, ischemic heart disease, and migraine. Older residents in Fairfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.6%) and annual dental exams (72.4%), while 49.5% of men and 44.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include four assisted living facilities, 55 primary care providers, one hospice agency, 12 community health centers, two senior centers, and two public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (<u>healthyagingdatareports.org</u>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
