
East Hartford (Hartford)

East Hartford is a town in Hartford County with 7,026 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, benign prostatic hyperplasia, cataract, fibromyalgia/chronic pain/fatigue, glaucoma, osteoarthritis/rheumatoid arthritis, osteoporosis, and prostate cancer. However, they have higher rates of chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, hypertension, peripheral vascular disease, tobacco use disorder, PTSD, and schizophrenia. Older residents in Hartford County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (77.9%) and annual dental exams (69.2%), while 46.5% of men and 47.1% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 29 primary care providers, two home health agencies, one skilled nursing facility, one hospice agency, 14 community health centers, two Alzheimer's caregiver support group, two adult day health centers, two senior centers, and two public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
