
## **Farmington (Hartford)**

Farmington is a town in Hartford County with 5,432 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of anemia, benign prostatic hyperplasia, chronic obstructive pulmonary disease (COPD), diabetes, liver disease, peripheral vascular disease, substance and tobacco use disorders, and schizophrenia. However, they have higher rates of Alzheimer's disease or related dementias, cataract, glaucoma, and osteoporosis. Older residents in Hartford County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (77.9%) and annual dental exams (69.2%), while 46.5% of men and 47.1% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include four assisted living facilities, 152 primary care providers, one hospital, four home health agencies, two skilled nursing facilities, two hospice agencies, one senior center, three public universities or community colleges, and two public libraries.

## **TECHNICAL NOTES**

\*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (<a href="https://nealthyagingdatareports.org">healthyagingdatareports.org</a>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <a href="not">not</a> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
