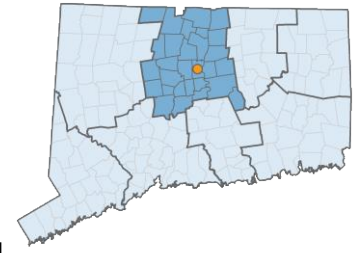


Hartford (Hartford)

Hartford is a city in Hartford County with 13,726 residents aged 65+. Compared to state average rates, older residents have lower rates of high cholesterol, atrial fibrillation, benign prostatic hyperplasia, cataract, endometrial cancer, fibromyalgia, migraine, arthritis, and prostate cancer. However, they have higher rates of Alzheimer's disease, anemia, asthma, chronic kidney disease, CHF, diabetes, heart attack, hypertension, ischemic heart disease, liver disease, osteoporosis, peripheral vascular disease, pressure ulcer, stroke, substance/tobacco use disorders, depression, anxiety disorder, PTSD, and schizophrenia. Residents in the county varied in obtaining preventive health screenings: residents 18+ got annual physical exams (77.9%) and dental exams (69.2%), while 46.5% of men and 47.1% of women 65+ completed all CDC recommended vaccinations and screenings. Community resources include 7 assisted living facilities, 479 PCPs, 3 hospitals, 3 home health agencies, 4 skilled nursing facilities, 20 community health centers, 3 adult day health centers, 5 senior centers, 4 public universities/community colleges, and 7 public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
