
## **Harwinton (Litchfield)**

Harwinton is a town in Litchfield County with 1,101 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, anemia, asthma, congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatique, ischemic heart disease, tobacco use disorder, anxiety disorder, and schizophrenia. However, they have a higher rate of cataract. Older residents in Litchfield County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.9%) and annual dental exams (72.1%), while 48% of men and 39.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one senior center and one public library.
