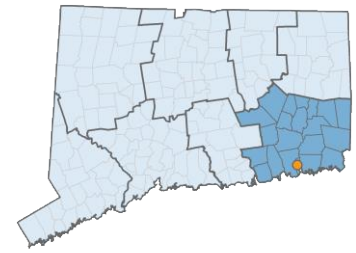


## New London (New London)

New London is a city in New London County with 4,063 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of atrial fibrillation and cataract. However, they have higher rates of Alzheimer's disease or related dementias, anemia, asthma, chronic kidney disease, chronic obstructive pulmonary disease (COPD), diabetes, fibromyalgia/chronic pain/fatigue, hypertension, liver disease, peripheral vascular disease, stroke, substance and tobacco use disorders, depression, anxiety disorder, PTSD, and schizophrenia. Older residents in New London County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (78%) and annual dental exams (72.6%), while 56.1% of men and 41.6% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include three assisted living facilities, 49 primary care providers, one hospital, two skilled nursing facilities, four community health centers, one senior center, and one public library.

## TECHNICAL NOTES

\*For more information on data sources, measures, and methodology used in the 2025 Connecticut Healthy Aging Data Report see our technical documentation at ([healthyagingdatareports.org](http://healthyagingdatareports.org)). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
