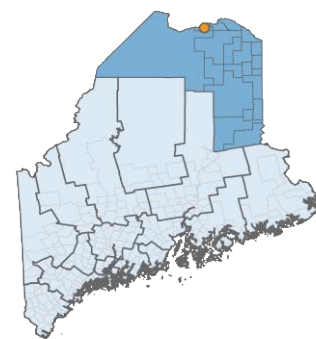


## Fort Kent (Aroostook)

Fort Kent is a town in Aroostook County with 835 residents aged 65 and older. Compared to state average rates, older residents have a lower rate of glaucoma. However, they have higher rates of high cholesterol, asthma, benign prostatic hyperplasia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), colon cancer, congestive heart failure (CHF), diabetes, hypertension, ischemic heart disease, liver disease, osteoarthritis/rheumatoid arthritis, peripheral vascular disease, anxiety disorder, and schizophrenia. Older residents in Aroostook County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (81.1%) and annual dental exams (59.8%), while 43.1% of men and 36% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 18 primary care providers, one hospital, one skilled nursing facility, four community health centers, one public university or community college, and one public library. Fort Kent is a designated AARP Age-Friendly Community.

## TECHNICAL NOTES

\*For more information on data sources, measures, and methodology used in the 2025 Maine Healthy Aging Data Report see our technical documentation at ([healthyagingdatareports.org](https://healthyagingdatareports.org)). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
