
Caribou, Connor, Washburn, Woodland (Aroostook)

The cities and towns of Caribou, Connor, Washburn, and Woodland are located in Aroostook County. Collectively, these areas are home to 2,598 residents aged 65 and older. Compared to state average rates, older residents have a lower rate of glaucoma. However, they have higher rates of high cholesterol, Alzheimer's disease, anemia, asthma, benign prostatic hyperplasia, cataract, chronic kidney disease, COPD, colon cancer, CHF, diabetes, heart attack, hypertension, ischemic heart disease, osteoporosis, tobacco use disorder, anxiety disorder, and schizophrenia. Older residents in Aroostook County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (81.1%) and annual dental exams (59.8%), while 43.1% of men and 36% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources include 24 primary care providers, one hospital, two home health agencies, two skilled nursing facilities, three community health centers, one senior center, and two public libraries. Caribou is a designated AARP Age-Friendly Community.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Maine Healthy Aging Data Report see our technical documentation at (<u>healthyagingdatareports.org</u>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
