
## **Chebeague Island, Harpswell, Long Island (Cumberland)**

The communities of Chebeague Island, Harpswell, and Long Island are located in Cumberland County. Collectively, these areas are home to 2,206 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, anemia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), colon cancer, congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatigue, heart attack, hypertension, ischemic heart disease, migraine, peripheral vascular disease, stroke, substance and tobacco use disorders, depression, and anxiety disorder. However, they have a higher rate of prostate cancer. Older residents in Cumberland County varied in obtaining preventive health screenings: residents 18 and older got annual physical exams (77.5%) and annual dental exams (73.2%), while 54.5% of men and 43.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include four public libraries.

## TECHNICAL NOTES

\*For more information on data sources, measures, and methodology used in the 2025 Maine Healthy Aging Data Report see our technical documentation at (<a href="healthyagingdatareports.org">healthyagingdatareports.org</a>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
