Hudson (Hillsborough)

Hudson is a town in Hillsborough County with 4,750 residents aged 65 or older. Compared to state average rates, older residents have a lower rate of PTSD. However, they have higher rates of anemia, asthma, chronic kidney disease, diabetes, heart attack, hypertension, ischemic heart disease, lung cancer, peripheral vascular disease, anxiety disorder, and high cholesterol. Older residents in Hillsborough County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (69.8%), while 47.8% of men and 38.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include seven primary care providers, one skilled nursing facility, one senior center, one assisted living facility, and one public library.
