Jaffrey (Cheshire)

Jaffrey is a town in Cheshire County with 869 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of schizophrenia and high cholesterol. Older residents in Cheshire County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (66.3%) and annual dental exams (65.5%), while 50.1% of men and 41.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include two primary care providers, one skilled nursing facility, and one public library.
