
## **Kingston (Rockingham)**

Kingston is a town in Rockingham County with 1,374 residents aged 65 or older. Compared to state average rates, older residents fare better on one healthy aging indicator with a lower rate of hip fracture. However, they have higher rates of anemia, atrial fibrillation, chronic obstructive pulmonary disease (COPD), liver disease, lung cancer, and high cholesterol. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one primary care provider and one public library.
