
Lancaster (Coös)

Lancaster is a town in Coös County with 729 residents aged 65 or older. Compared to state average rates, older residents fare better on one healthy aging indicator with a lower rate of osteoarthritis/rheumatoid arthritis. However, they have higher rates of diabetes, pressure ulcer, depression, and schizophrenia. Older residents in Coös County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.3%) and annual dental exams (56.9%), while 46.2% of men and 35% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include ten primary care providers, one hospital, one skilled nursing facility, and one public library.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 New Hampshire Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
