
## **Londonderry (Rockingham)**

Londonderry is a town in Rockingham County with 3,858 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, PTSD, and schizophrenia. However, they have higher rates of asthma, cataract, chronic kidney disease, fibromyalgia/chronic pain/fatigue, hypertension, peripheral vascular disease, and high cholesterol. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 35 primary care providers, two home health agencies, one senior center, and one public library. Londonderry is a designated AARP Age-Friendly Community.
