
## **Madison (Carroll)**

Madison is a town in Carroll County with 510 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, anemia, chronic kidney disease, diabetes, heart attack, ischemic heart disease, lung cancer, peripheral vascular disease, tobacco use disorder, depression, and schizophrenia. Older residents in Carroll County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.6%) and annual dental exams (66.3%), while 53.8% of men and 40.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library. Madison is a designated AARP Age-Friendly Community.
