
Manchester (Hillsborough)

Manchester is a city in Hillsborough County with 16,568 residents aged 65 or older. Compared to state average rates, older residents have higher rates of Alzheimer's disease, anemia, asthma, chronic kidney disease, COPD, CHF, diabetes, fibromyalgia, glaucoma, hypertension, ischemic heart disease, liver disease, osteoporosis, peripheral vascular disease, pressure ulcer, stroke, substance/tobacco use disorders, depression, anxiety disorder, PTSD, schizophrenia, and high cholesterol. Older residents in Hillsborough County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (69.8%), while 47.8% of men and 38.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources include 278 PCPs, 2 hospitals, 3 home health agencies, 9 skilled nursing facilities, 1 hospice agency, 21 community health centers, 1 adult day health, 1 assisted living facility, 1 senior center, 3 public universities or community colleges, 2 public libraries, and an Alzheimer's caregiver support group. Manchester is a designated AARP Age-Friendly Community.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 New Hampshire Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
