
## **North Hampton (Rockingham)**

North Hampton is a town in Rockingham County with 1,135 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, Alzheimer's disease or related dementias, asthma, chronic obstructive pulmonary disease (COPD), diabetes, tobacco use disorder, and schizophrenia. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one public university or community college and one public library.
