
Nottingham (Rockingham)

Nottingham is a town in Rockingham County with 1,008 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of anemia, cataract, chronic kidney disease, congestive heart failure (CHF), and osteoporosis. However, they have a higher rate of PTSD. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
