Orford (Grafton)

Orford is a town in Grafton County with 332 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, anemia, benign prostatic hyperplasia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, hypertension, ischemic heart disease, liver disease, lung cancer, peripheral vascular disease, pressure ulcer, substance and tobacco use disorders, and anxiety disorder. Older residents in Grafton County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (70.4%) and annual dental exams (67.2%), while 48.6% of men and 42.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one senior center and two public libraries.
