
Pittsburg (Coös)

Pittsburg is a town in Coös County with 354 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, glaucoma, liver disease, depression, anxiety disorder, and schizophrenia. However, they have higher rates of diabetes, hypertension, and PTSD. Older residents in Coös County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.3%) and annual dental exams (56.9%), while 46.2% of men and 35% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
